The Management of M/s GVK Chinmanya Vidyalaya School, Located at Sy.No:144A1, 145A, 145B, 146F & 146G, Kothur(V), Indukurpet(M), SPSR Nellore District has requested to issue Periodical Occupancy Renewal Certificate.

2) The No Objection Certificate for Occupancy and Renewal No Objection Certificates were issued vide reference 1<sup>st</sup> to 5<sup>th</sup> cited above respectively to the existing building of M/s GVK Chinmanya Vidyalaya School, Located at Sy.No:144A1, 145A, 145B, 146F & 146G, Kothur(V), Indukurpet(M), SPSR Nellore District with Ground + Three(3) Upper Floors with a Height of 14.63 Mtrs., with Built-up area of 6645.20 Sq.Mtrs., for Educational(B1) Occupancy.

3) The MSB Inspection Committee has inspected the existing building of M/s GVK Chinmanya Vidyalaya School, Located at Sy.No:144A1, 145A, 145B, 146F & 146G, Kothur(V), Indukurpet(M), SPSR Nellore District and tested the working condition of Fire Fighting equipment and found in good working conditions vide reference 10<sup>th</sup> cited.

4) In view of the above, based on the Inspection Committee Report, the Periodical Occupancy Renewal Certificate is issued to the existing building of M/s GVK Chinmanya Vidyalaya School, Located at Sy.No:144A1, 145A, 145B, 146F & 146G, Kothur(V), Indukurpet(M), SPSR Nellore District with Ground + Three(3) Upper Floors with a Height of 14.63 Mtrs., with Built-up area of 6645.20 Sq.Mtrs., for Educational(B1) Occupancy. 1.	All the fire protection arrangements shall be maintained in good repair as seen during inspection.	All the escape / exit roots shall not be kept locked / blocked or encroached.	All the occupants must know the correct method of operation of the fire fighting system installed
2.	Any loss of life or property due to non-functioning of fire safety measures and other installations shall be the responsibilities of the management.	All occupants shall be trained to operate the fire safety equipments during emergency.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.
3.	Addition / alteration, if any in the building may be verified by building authority.	Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.	All security personnel shall be trained to operate the fire safety equipments during emergency.
4.	This Periodical Occupancy Renewal Certificate is only from Fire Safety Point of View.	Raise the alarm If the fire cannot be controlled, evacuate the area completely at once with nearest safe exit. 
5) The Management shall ensure the following conditions:

- i. The Management is responsible for all risks involved in case of Fire Accident.
- ii. This Periodical Occupancy Renewal Certificate is given based on the Self Certification, Documents and Drawings provided by the Applicant. The Management confirms that the information provided and the Documents and Drawings submitted are correct. Any deviation noticed will lead to cancellation of NOC without any notice.
- iii. The permission accorded does not confer any ownership rights. If it is found that the information furnished is false and fabricated, the permission will be revoked at any stage and the Applicant will be liable for criminal prosecution as per IPC.

6) This **Periodical Occupancy Renewal Certificate is valid for a period of Five (03) years** from the date of issue of this NOC to the management of M/s GVK Chinmanya Vidyalaya School, Located at Sy.No:144A1, 145A, 145B, 146F & 146G, Kothur(V), Indukurpet(M), SPSR Nellore District. The Owner/ Occupier/Builder/Management concerned of the Building shall submit Affidavit/Self Declaration/Certification with regard to working condition of above Fire Safety system and Electrical Safety Compliance report every year in the prescribed format and submit/upload the photographs of the Mock Drills conducted in the premises.

7) It is the responsibility of the Builder/ management of M/s GVK Chinmanya Vidyalaya School, Located at Sy.No:144A1, 145A, 145B, 146F & 146G, Kothur(V), Indukurpet(M), SPSR Nellore District to maintain the Fire Safety equipment in good working condition at all times and apply for next Periodical Occupancy Renewal Certificate, duly remitting the User Charges vide G.O.Ms.No.90, Home (Prisons & Fire Services) Department, Dated: 13.08.2021 & G.O.Ms.No.120, Home (Prisons & Fire Services) Department, Dated:25.10.2021, two (02) months before expiry of this Renewal of No Objection Certificate.
